Homes Previously, you could deduct up to \$500 per interest payment on a home you owned that was your primary home. The interest payments had to be made on the debt that became the basis for the home. This taxable interest exclusion was available if the home was: your principal home used for a trade or business or as a vacation home You were entitled to the exclusion. however, if the property: was replaced by a new home or was improved with new buildings or was used for a purpose other than the home on which the interest was paid. You must still deduct the interest payments, but the amount of the deductible loss decreases as the amount of the mortgage exceeds the basis of the home. You can still deduct interest paid on second home mortgages and associated indebtedness. You can deduct the interest on debts incurred to purchase or to improve the home. In this case, you must be able to show the amount of the indebtedness was used to purchase or improve the home. Notice: You can deduct interest on a home you rent out. This includes rentals you own. However, rental income is not a qualified use of the home for interest deduction purposes. Interest on debts incurred to finance the purchase or improvement of a qualified residence, including a second home, is also deductible.
